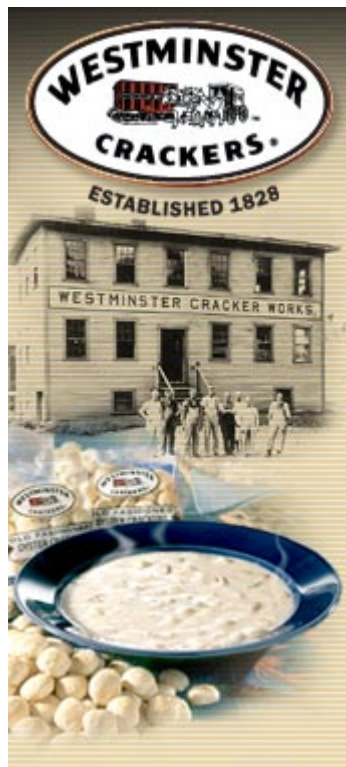

Directions to Westminster Cracker Company, and to Table 24 Restaurant

Westminster Cracker Co. from the north: Going south on Route 7, at 0.8 miles south of where Route 4 first joins Route 7, take a right onto Park St. Take the immediate next right, Porter Pl., which after the first intersection turns into Scale Ave. Look for Building 11 (near 3 silos).

Westminster Cracker Co. from the south: Going north on Route 7, at 1.3 miles north of where Route 4 first joins Route 7, take a right onto Park St. Take the immediate next right, Porter Pl., which after the first intersection turns into Scale Ave. Look for Building 11 (near 3 silos).

To the restaurant from Westminster: Head out northwest on Scale Ave., turn left at Strongs Ave., and then 0.3 miles later take a right onto Wales Street. The restaurant is on your right 0.2 miles later.

Vermont State Science and Mathematics Fair

As one of its regular activities, our Local Section participated in the Vermont State Science and Mathematics Fair which was held at Norwich University, on Saturday, March 28, 2009. The experienced team of judges consisted of Green Mountain Local Section officers Fiona Case, Martin Case, and Willem Leenstra.

Our top Green Mountain Local Section award is accompanied by a \$100 prize, and was won by Brian Ribbans, a twelfth-grade student at Mount St. Joseph Academy in Rutland. His project was a study of "The Purification of Waste Vegetable Oil into Biodiesel".

Report from our Councilor, Willem Leenstra



I attended the Council meeting at the Spring National Meeting just held in Salt Lake City, Utah, March 22-26, 2009. What follows are the highlights and the more interesting announcements from that meeting. Election Results

By electronic ballot, the Council selected Nancy B. Jackson and Cheryl A. Martin as candidates for 2010 President-Elect. These two candidates, along with any candidates selected via petitions, will stand for election in the Fall National Election.

Our District I Director, Anne O'Brien, is now in her last term on the Board of Directors. After receiving the names of four candidates to run for that seat from N&E, Councilors voted to put forward the names of Richard Cobb and Neil Jespersen. They will be on the ballots that all of our GMLS members will receive in the beginning of October, 2009. Richard Cobb's name should be known to those who attended NERM2008 as the Chair of the Awards Committee.

Petitions for Bylaw Changes

As its only noteworthy item, the Council received one petition for consideration: the Petition on Election Timelines 2009. According to the proposing committee (N&E), this petition presents election procedure refinements in the dates on which names of candidates for elected officers must be presented, as well their consequent timelines. Action is expected on the petition at the fall Council meeting.

2009 Member Dues

After a lengthy discussion and rejection of two amendments, the Council VOTED to set the member dues for 2010 at the fully escalated rate of \$145. This rate is established pursuant to an inflation-adjustment formula in the ACS Constitution and Bylaws.

The Society's Finances

The Society ended 2007 with a net from operations of \$9.6 million, which was \$2.2 million favorable to the approved budget. This was based on total revenues of \$444.2 million and total expenses of \$434.6 million. The Society ended the year in full compliance with the Board-established financial guidelines.

Salt Lake City Attendance

At last count, the ACS spring national meeting had attracted 10,668 registrants, distributed over the various categories as follows: regular attendees 5,781; students 3,439; exhibitors 780; exposition only 411; and guests 257.

Member Statistics

At the close of 2008, Society membership totaled 154,024, compared to 160,052 for year-end 2007. In 2008, ACS completed the transition of its 15 year-old membership fulfillment system to a new, more robust system. The year-end 2008 membership numbers reflect a drop in membership of approximately 2% due to the economy and a correction to the counts of 2,589 Emeritus members whom ACS has not been able to reach for many years. Notes from the Council Committee on Meetings and Expositions

In my position as Chair of a major Council committee, the Committee on Meetings and Expositions (M&E), a number of important issues were addressed. These include: selecting sites for the 2019 national meetings, review of the 2008 regional meetings, and installing new protocols to increase participation in the Exposition.

Related to the subject of managing the technical program, we have found it necessary to more clearly reiterate the standing ACS policy regarding photography and videography of oral and poster presentations. In an article that appeared in the March 2, 2009, issue of C&E News, I was interviewed and explained our policy.
